Huron Fire Fiscally Responsible in Truck Replacement



The City of Huron is excited to finally take possession of our “new to us” fire truck to support the ongoing needs of the Huron Fire Department and to further enhance emergency response services throughout the community.

The newly acquired apparatus, a preowned 2006 Sutphen SPH 100 aerial ladder truck, was purchased for \$479k, representing a significant cost savings compared to a new unit, which can exceed \$2.1 million and often requires a two-to-three-year window for delivery.

“This purchase allows us to maintain a high level of service while being responsible stewards of public funds,” said Fire Chief Kevin McGraw. “The apparatus is in excellent condition and will serve as a critical resource for our firefighters and residents.”

The pre-owned truck is considered a “quint”, an apparatus that combines the equipment capabilities of a ladder truck and the water-pumping ability of an engine. As its name implies, it features five main tools (pump, water tank, fire hose, aerial device, and ground ladders) to carry out firefighting operations. This will allow the department to have everything they need when responding to an emergency. Its integration into the fleet provides added redundancy, helping maintain service continuity during maintenance cycles or high-demand periods. It is the hope of the Department that the Sutphen will serve the Huron community well for the next 10-12+ years. “This decision reflects a balanced approach to maintaining

high-quality service without overextending financial resources,” stated Chief McGraw.

The addition of the preowned truck addresses the immediate need to replace the 29-year-old Seagrave ladder truck which recently experienced a major issue leaving it non-functional for its purpose. With no replacement parts in existence and fabricators expressing concern over engineering a second new part in five years, the Department made the decision to search for a preowned truck as its replacement. The Seagrave will be stripped of all its accessories and gear and then sold on GovDeals. The average lifespan for most apparatus is approximately 20 years.

“This investment ensures that our fire department remains fully equipped to respond to emergencies without interruption,” said City Manager Stu Hamilton. “Public safety remains our top priority.”

The City continues to navigate tightening budgets and rising costs, making difficult decisions about funding essential services have become unavoidable. As the Huron Fire Department places a levy on the upcoming ballot, it remains committed to demonstrating fiscal responsibility.

“This acquisition underscores the Department’s commitment to fiscal responsibility, operational readiness, and the safety of the community it serves,” stated Huron City Manager Stu Hamilton. “Residents can take confidence in knowing that the fire department continues to make thoughtful decisions that maximize both effectiveness and value.”

Nickel Plate Beach Seasonal Passes
 Nickel Plate Beach Seasonal Parking Passes are now available online. Be beach ready, order your pass online today and it will be mailed to the address provided prior to opening season. The Nickel Plate Beach Parking Pass entitles the registered holder the ability to park one licensed vehicle at Nickel Plate Beach during beach hours (dawn to dusk), for the 2025 Season, Memorial Day through Labor Day. A seasonal parking pass sells for \$25 for residents and \$40 for non-residents. A daily pass is also available at the entry gate for \$7 a vehicle per day. Season passes may be purchased at the gate as well.

No Refunds if the beach is closed due to unforeseen events.

As a reminder, City Ordinance prohibits dogs on the beach or in the park from 10 AM until 6 PM Memorial Day through Labor Day. As always, there are no life-guards on duty at Nickel Plate Beach. City and Huron River Fest Combine Resources

In celebration of the United States of America's 250 years of independence, communities across the U.S. are making plans to mark the Semiquincentennial with special events, ceremonies, programs, and more.

Local leaders and members of the non-profit, Huron River Fest, met with officials from the City of Huron to explore ways to enhance Huron's summertime traditions and celebrations while incorporating a nod to America 250.

On Saturday, July 4th, residents and visitors can gather at the Huron Boat Basin Amphitheater for a night of Red, White and Blues designed to celebrate America's 250th Anniversary. The festive evening will kick off at 6 p.m. with Cleveland's Backstreet Blues Band, one of the most engaging and fun blues bands around, followed by E.T. King & The Determination, a legendary band from northeast Ohio known for their authentic sounds of Motown, R&B, blues, funk and more. A variety of food trucks and drink options will also be available.

Following the Red, White and Blues celebration on the 4th of July, the ever-so-popular Huron River Fest will return just six days later to the Huron Boat Basin on July 10 and 11, 2026. With over three decades of traditional family fun, including a 5k Race/1 mile Fun Run and Walk, the Lion's Club Parade, carnival rides and games, a variety of live music and entertainment on-stage, along with various food and drink vendors, there is a little something for everyone.

Instead of hosting two separate fireworks shows just six nights apart and competing with other area 4th of July displays, the idea of combining resources led to the creation of a single, larger-scale fireworks this year in honor of the America 250 celebration. The enhanced display will take place on Friday, July 10, 2026, during River Fest, with a rain date of Saturday, July 11, 2026.

By pooling funds into a single show, the city of Huron and Huron River Fest can significantly enhance the fireworks display while avoiding the added expenses associated with producing multiple events, including setup, staffing, safety, and logistics.

"This decision allows us to stretch every dollar further," said Stu Hamilton, Huron City Manager. This collaborative approach reduces duplication of efforts, ultimately having a greater impact on the community and delivering a more polished and memorable event at a sustainable cost for both the City and Huron River Fest.

"By joining forces to create one larger evening of fireworks, we are not only honoring the America 250 celebration, but also strengthening the sense of connection that defines our community," stated the Huron River Fest Committee.



Lake Erie Electric Trail Connector

The city applied for and was awarded a grant from the Ohio Department of Transportation (ODOT) Transportation Alternatives Program (TAP) to help fund a connection between the Lake Erie Electric Trail and the soon to be constructed US6 Connectivity multi-use pathway connecting BGSU to Sandusky and beyond. By adding this connection, users will be able to safely access the multi-use pathway from the Electric Trail while broadening their ability to travel further either by foot or by bicycle.

The City is very appreciative of the \$533,000 funding from ODOT's TAP and their interest and support of the connectivity projects.

OHM Advisors were selected through a competitive process in March and have begun working on the proposed route and ROW requirements for the connector.

An ODOT site walkthrough was conducted in January, at which time the final Scope of Services was agreed upon. The next step will be to award a bid for design services for this project. With ROW/easements being required to install this pathway, we do not anticipate the construction starting until 2027.





Projects Around Town

US 6, Phase II

The City has been given the green light to move forward with the transformative project of constructing a roundabout at US 6 and Liberty Avenue.

The US 6, Phase II project is set to begin in the very near future. The project will check off a number of issues that have been lingering in the area of US 6, Center Street, and Jim Campbell Blvd., such as, the removal of the unwarranted traffic light at US 6 and Center Street, alleviate the confusion of the US 6, Jim Campbell Blvd., and Center Street intersection by closing Jim Campbell Blvd. at the eastern terminus and will slow traffic entering and leaving the City from Route 2, all while creating a more aesthetically pleasing entrance or gateway into the downtown area of Huron.

The plan includes extending the bike lane from Williams Street, where it currently ends, west through Van Rensalaer. Future plans include adding a multi-modal pathway along Jim Campbell to connect the bike path at Van Rensalaer to the Lake Erie Electric Trail.

The US 6, phase II project will require an (up to) 60-day full closure of Rt 6 west of Center St. Once the project plan is in place, a detailed schedule and detours will be shared.



Bike Lane Repainting

The Huron bike lane will take on a new look this spring as the Ohio Department of Transportation (ODOT) has updated bike lane marking standards. The work to be completed on the bike lane extends from Berlin Road to Williams Street through town. The paint in the current footprint will first be blasted off, followed by cracksealing and application of new paint. The current white stripes and symbols will be painted with a high-visibility white paint. The green areas of the bike lane will be limited to 25 feet on either side of an intersection and the bridge decks. The new design drastically reduces the amount of paint on the lane.

SealMaster of Sandusky has offered to apply the green paint at no charge with the City covering the actual cost of the paint. The City is grateful for their partnership and looks forward to working with them on this project.

This project is tentatively scheduled to take place later this month, weather dependent.

ConAgra Spring Update

The ConAgra site is never far from our planning table. The developer, Triban Investments is close to finalizing their due diligence and once complete, we can move to close on the property sale. Triban Investment consists of development partners Knez Homes and K. Hovnanian Homes (one of the nation's largest homebuilders). Their plan is to construct 95 multi-family units on the site, along with amenities and a restaurant space. A public access walkway around the perimeter of the property will remain in place for public use.





Celebrating the Career and Retirement of Julie Ortega

After 29 years of dedicated service, Clerk of Courts, Julie Ortega, retired from the Huron Municipal Court late this past October, marking the conclusion of a career defined by leadership, commitment, and lasting impact.

Joining the Huron Municipal Court in 1996 as the Clerk of Courts, Julie has adapted to a variety of changes over the past three decades. During her tenure, she experienced multiple changes in leadership, ironically four Judges, four Police Chiefs, and four City Managers, all contributing to Huron's past and present. In addition to the City leadership, other changes included keeping up with the court system and its ever-changing laws, legislation, and bills. One physical change Julie recalled was the major renovation of the physical court room during the Mike Tann and Lee McDermitt era.

Over the years, Julie has held a variety of roles of increasing responsibility, including developing a Probation Department for the Court, positively contributing to the City's General Fund and holding a board position on the Clerk of Courts Association, Ohio.

Upon beginning her career in 1996, Julie immediately saw a need for a Probation Department with the Court. After defining the parameters and program basics, Julie trained one of the clerks to be 50% Deputy Clerk and 50% Probation Officer. Julie's work on developing this program not only strengthened operations but also set a standard that continues to guide the Court today. "I have seen too many people heading down the wrong road, it was important for me to help make a difference by offering a means to redirect them. To this day, it feels good to see someone who has benefitted from the program," explained Julie.

Another huge accomplishment for the Municipal Court under Julie's tenure is positively contributing to the City's

General Fund. While many courts can often be a drain or a burden on a government, where Huron Municipal Court takes great pride in holding their own and contributing to the General Fund. "In my 29 years with the court, only once there was a shortfall, during the global pandemic of 2020," stated Julie.

A personal career goal for Julie was to sit as a Board Member on the Clerk of Courts Association for Ohio. As a Board Member, Julie held roundtable classes for newly appointed Clerks around the state. "In this job, getting to know other clerks and having contact with other Courts offers the opportunity to learn new functions." Through each chapter of her career, Julie has played a vital role in shaping the Court's growth and success.

Reflecting on her career, Julie shared pride in how the organization has evolved. "I've had the privilege of watching the Court grow and adapt, and I'm proud to have been a part of that journey," she said. Julie plans to remain active with the Court as a part-time Deputy Clerk for the time being.

"I am grateful to have had Julie serve as our Huron Clerk of Court for many years. Her insight and expertise have been vital to the daily success of our court. Understanding the Rules of the Road for all Users

As the weather shifts to more spring-like conditions, more people are going outside to walk, bike, exercise, explore, and enjoy Huron!

With the popularity of e-bikes and e-scooters exploding over recent years there has been a considerable amount of concern for safety and confusion over the rules of the road.

The graphics below identify each "E" mode of transportation, their abilities and limits, and acceptable locations for use.

As a reminder:

- ALL modes of transportation, including traditional pedal push bicycles and scooters and e-bikes and e-scooters are required to OBEY ALL TRAFFIC LAWS when traveling on city streets.

- o Obey all traffic signals and signs
- o Use hand signals for turns
- o Ride in the same direction as traffic
- o Use bike lanes when available

- Bicycles, scooters, e-bikes (excluding class 3 e-bikes), and e-scooters are permitted to travel on the sidewalks; however, e-bikes and e-scooters may only do so under push power and NOT in "pedal assist" or the "throttle" mode.

- All riders of bicycles, scooters, e-bikes and e-scooters are highly encouraged to wear helmets.

- When traveling in crowded areas or passing pedestrians use extra caution.

E-Bike and E-Scooter Basics & Classifications

Class 1 E-bikes

- Pedal Assist Only
- Max. speed 20 mph
- Max. 750W motor (1-horsepower)
- No Throttle
- No statewide minimum age
- Permitted on shared-use paths and bike lanes
- Permitted on sidewalks ONLY when NOT USING the motor
- Class 1 often includes: mountain bikes, townies, low-end commuters, and hybrids

Class 2 E-bikes

- Pedal Assist and has a THROTTLE
- Max. speed up to 20 mph
- Max. 750W motor (1-horsepower)
- No statewide minimum age
- Permitted on shared-use paths and bike lanes
- NOT permitted on SIDEWALKS
- Class 2 E-bikes are more or less a low-end scooter and are a low-to no-exercise form of transportation

Class 3 E-bikes

- Pedal Assist
- Max. speed up to 28 mph
- Max. 750W motor (1-horsepower)
- Must be 16+ yrs or older to operate
- Speedometer Required
- Helmet Required
- NOT PERMITTED on shared paths, bike lanes, or sidewalks
- Class 3 E-bikes include high end commuters, cargo bikes, gravel bikes, and road bikes

E-Scooters

- An e-scooter is an electric motorized scooter where the rider stands up on a large deck centered over 2 wheels and is propelled by an electric motor.
- An E-Scooter is NOT considered a motor scooter, a motorcycle, or a non-motorized scooter
