REQUEST FOR BIDS

Sealed bids will be received by the City of Huron, Ohio (“Owner”), at the office of the City Manager, Huron City Hall, 417 Main Street, Huron, Ohio 44839 on the 17th day of November 2025 until 2:00pm current local time for the:

“Huron Public Power Substation Expansion - 15kV Construction and Installation Work”

and will be publicly opened and read immediately thereafter. The **15 kV Construction and Installation Work at Huron Public Power Substation** at 1156 Rye Beach Road includes installation of new 15 kV switchgear sections furnished by City, related concrete foundation and cable vault, underground conduits and cables, connections to new power transformer furnished and installed on foundation by City, interconnection control wiring and auxiliary station power distribution modifications.

Each bid must contain the full names of the party or parties making the same, with an affidavit as to the interested parties, and in the case of a corporation not chartered in Ohio, with a proper certificate that such corporation is authorized to do business in Ohio, and shall be accompanied by a Bid Guaranty Bond for the full amount (100) of the Bid, in favor of the “Owner” or a certified check, cashier’s check, or letter of credit pursuant to Chapter 1305 of the Ohio Revised Code, in the amount of the Bid, payable to the “Owner”.

It is agreed that the bid guaranty shall be for the benefit of the “Owner” pursuant to Section 153.54 of the Ohio Revised Code if the undersigned fails to execute the Contract in conformity with the Form of Contract incorporated in the contract documents and furnish Bond and insurance certificates within ten (10) days after the notification of the award of the Contract to the undersigned.
