American Hornbeam - Carpinus Genus (All species)
Golden Raintree Koelreuteria paniculata
Lilac Ivory Silk – Syringa reticulata
Redbud
Serviceberry – Amelanchier
Sugar Tyme Crabapple - Malus 'Sugar Tyme'

Medium 30-45' – not appropriate for under utilities

Black Gum Tupelo – Nyssa sylvatica
Linden (little leaf) – Tilia cordata
Sunburst Honeylocust - Gleditsia triacanthos inermis 'Sunburst'

Large – 45'+ - appropriate where tree lawn is greater than 10' & no power lines

American Hophornbeam – Carpinus caroliniana
Bur Oak – Quercus macrocarpa
Chinkapin Oak – Quercus muehlenbergii
European Hornbeam – Carpinus betulus Ginkgo Sentry – Princeton sentry – male only Ginkgo biloba "Princeton Sentry"
Green Mountain Sugar Maple - Acer saccharum 'Green Mountain'
London Plane Tree – Platanus x acerifolia
Northern Red Oak – Quercus rubra
Red Oak - Quercus rubra
Sawtooth Oak – Quercus acutissima
